To further the goal of providing affordable health insurance to Federal employees, the United States Office of Personnel Management (OPM) has issued a final rule modifying coverage under the Federal Employees Health Benefits (FEHB) Program to include certain temporary, seasonal, and intermittent employees who are identified as full-time employees. This regulation makes FEHB coverage available to these newly eligible employees no later than January 2015.

 - i. Dr. Townsend comment. There is a lot of information concerning the Choice Act. If a veteran lives 40 miles from a VA facility or

those that are waiting over 30 days they will be given a Choice Card. This is a 3 year program until the VA can create internal capacity to provide quicker access.

- 3. Optometric Education Programs Drs. Slagle/Messer
 - a. Dr. Townsend comment for Dr. Slagle. The Health Services Training Report (RCS 10-0161) is open for data entry. This report is a count of all students and/or residents who spent at least 40 hours at your facility in clinical education training that was required by their degree program. This information is used to report on the VA's significant contributions to the education and training of health care professionals. The report is due to OAA by December 5, 2014. Please work with your ACOS Education or Designated Education Official to complete this report.
 - b. The Director of Medical and Dental Education of the Office of Academic Affiliations issued a statement regarding trainees and their risk of exposure to Ebola-infected patients.

- i. Policy: Health professions trainees who participate in VA-based clinical educational experiences should not be subjected to excessive or unusual risks in their learning capacity. For that reason and also because of their relative inexperience, health professions trainees should not be tasked with participating in the care of Ebola virus patients in VA settings. Every effort should be made to avoid the exposure of trainees to potentially Ebola-infected patients or contaminated items.
- 4. COPE Approved EES Coursework Dr. Hetrick
 - a. Dr. Hetrick comment. Lisa Chan-O'Connell and Timothy Morand are going to be the co-leaders of the steering committee on the Continuum of Care Series for Low vision. They had their first meeting yesterday. She is in the process of establishing a SharePoint site.

- 6. Electronic Medical Records/Information Technology Issues Dr. Ballinger
 - a. Dr. Ballinger comment. There has been a recent announcement from the Open Source Electronic Heath Records Agency in regards to the development of the new Electronic Medical Records System.
 - i. The current naming of the System is called the Enterprise Health Management Platform (EHMP). This is a multiyear effort to evolve a modern service oriented enterprise application platform.
 - ii. This will comprise of a complete virtual patient electronic record and include information in terms of records from Do/D, exchange partners and the VA.
 - iii. The core modules that form the basis of this open source system have been developed. They are now working on developing plugins to this system.
 - iv. There is a VISTA exchange component, a clinical decisions support, context persistence, management services, order selection service, data annotation, improved clinical workflow, concept relationship services, documentation text services, and rules management systems.
- 7. Infection Control/Reusable Medical Equipment Reprocessing Drs. Horn/Mancil/O'Connor/White
 - a. Dr. Townsend comment. There are some lenses that do not touch the mucus membranes of the eye so they do not need to go through the same reprocessing procedures as those that do have direct contact.
 - b. There are also disposable Goldmann gonio lenses and 3M lenses that are available. Salem VAMC states that they use those lenses because the price is less then to reprocess nondisposable lenses through SPD. The optics are not as good but they work.
