 - a. Dr. Barker comment. They have been working on the practice guidelines for TBI, eye injury and combat casualty care. They have four draft sections including primary medical care guidelines, eye care providers, specialty eye care involving ocular motor dysfunction, and the rehabilitation of visual field loss. These have been developed by the joint DoD /VA workgroup. These documents are current in draft format. They now have direct contractors to help manage the formulation of more specific global practice recommendations by bringing these back to the field for validation.
