- a. Dr. Lum comment. All <u>funded</u> associated health trainees, including optometry residents, <u>must</u> be U.S. citizens. Funded training positions are considered to be national assets. No waivers will be granted based on local inability to recruit citizens. Exceptions require specific approval of the Under Secretary for Health and are generally not granted. Please ensure that you only recruit and rank US citizens if you desire funding for your residency positions. For more information, please reference VA Handbook 500, Part II, Chapter 3, Paragraph 3.g. (5) (c), dated August 12, 2005.
 - i. If you desire to appoint a non-U.S. citizen for your residency, you must first obtain approval for a W.O.C. appointment. W.O.C. appointments of non-citizen trainees may be approved by the facility Director. If this should be approved, please promptly contact Dr. Townsend's office so that Office of Academic Affiliations' funds may be temporarily reallocated to another facility. (Reference: VA Handbook 5005, Part II, Chapter 3, Section G, 6 b. (2), dated August 12, 2005.)

- 5. Electronic Medical Records/Information Technology Issues Dr. Ballinger
 - a. Dr Horn comment. The Chief Information Security Officer has now stated that in order to gain external remote access to VA computers you must use your PIV card, this mandate will take effect April 30, 2014. If you are unable to use your PIV card you will need to go to your local facility and obtain a waiver.
 - b. Dr. Ballinger comment. There is a CITRIX newsletter that talks about the gateways and configuration of PCs and PIV readers. Your local facility should have sent out information but Dr. Ballinger will send information to Dr. Townsend for dispersal.
 - c. Testing and development on accessibility in terms of connections between various sources has proceeded and more details are to come soon.
 - d. The module III of the training modules series for coding and billing should be coming out at the end of the month. This module will be on CPT coding. By now everyone should have in place most of their DSS stop codes set up correctly for their clinics. If you have not, please make sure you do so you can get credit for your workload.
 - e. ICD 10 has been delayed another year until October 2015.
